# 1. Property and Real Estate

## 1.1. Prices of Property and Real Estate

Prices for the occupation of Property and Real Estate are defined based on:

- » The Port zone in which the property is located;
- » Several criteria characterising the property within each zone;
- » The characteristics of the project for which the property is required.

The amount of the fee depends on the above three points and is defined by contract with the customer through an agreement for temporary occupation authorisation, the duration also depends on the customer's needs.

## 1.2. Fees without authorization

For any storage of goods, or occupation of the maritime public area without prior authorisation from the port or beyond the authorised period, a penalty fee is applicable.

**These fees without authorisation are invoiced as under:**

## 1.3. Short-term fee

For any occupation lasting less than or equal to 1 year, the costs of preparation, invoicing and any subjection useful for the management of the contract will be invoiced in addition to the amount of the fee up to 150.00 € excl. taxes.

## 1.4. Lack of contractual document

Failure of transmission in contractual document by the lessee will be invoiced 150.00 € excl. taxes to the first failure and 500 € excl. tax in case of lack of file or document of executed work (D.O.E.).

## 1.5. Rent of meeting room

Port Atlantique La Rochelle could rent an equipped meeting room (tables, chairs, paper-board, video-projector) for 15 persons. The inclusive price for the rental of such a room is 70 €/day excl. tax. The opportunity for a welcome coffee for 8 € (excl. taxes) per person per day is offered.

For other additional services see 2. *Services not referenced elsewhere*

## 2. Services not referenced elsewhere

Any service requested from the Port but not referenced in this "Service Provision" document, may, after a quotation and written agreement from the customer, be carried out at the actual cost of the service plus management costs as follows:

- 40 € excl. taxes for services lower than 1 000 € excl. taxes;
- 80 € excl. taxes for services greater than 1 000 € excl. taxes.

Unless specifically requested by customers, re-invoicing may be grouped together in order to limit management costs.

## 3. Complex and specialised installations

### 3.1. Tanker jetty

Services for providing superstructure equipment of the tanker jetty:

- » Per ton loaded, unloaded or transhipped: **0.2233 € excl. taxes/ton**
- » Laying and removal of gangways<sup>1</sup>
  - Taxable volume of the vessel  $\leq 18\,000\text{ m}^3$ : **387.50 € excl. taxes per call**
  - Taxable volume of the vessel  $> 18\,000\text{ m}^3$ : **701.20 € excl. taxes per call**

### 3.2. RoRo Station

#### a) Chef de Baie

Laying and removal of the station platform:

- » Per call: **2 648.99 € excl. taxes/call**

This fee for commissioning is entitled to the discounts listed below, from the start of service and for one year, for vessels of the same line, operator, or common service providing a regular business line:

- » 4 to 12 calls per year: **25%**
- » 13 to 24 calls per year: **35%**
- » Over 25 calls per year: **45%**

#### b) Lock basin

Use of the Ro-Ro ramp:

- » Per call: **1 324.50 € excl. taxes/call**

This fee for commissioning is entitled to the discounts listed below, from the start of service and for one year, for vessels of the same line, operator, or common service providing a regular business line:

- » 4 to 12 calls per year: **25%**
- » 13 to 24 calls per year: **35%**
- » Over 25 calls per year: **45%**

<sup>1</sup> The taxable volume of the vessel is established, depending on its physical characteristics, by the following formula:  $V = L \times b \times T_{\text{eau}}$  where  $V$  is expressed in cubic metres,  $L$ ,  $b$ ,  $T_{\text{water}}$  respectively represent the overall length of the vessel, its maximum width and its maximum draught in summer, and are expressed in metres and decimetres. References applicable are those published in Lloyd's Register or, failing that, in the "Ship's Particular" duly certified by the captain as of the day of the call.

The value of maximum summer draught of the vessel taken into account for the application of the above formula can in no case be less than the theoretical value equal to  $0.14 \times \sqrt{L \times b}$  ( $L$  and  $b$  are respectively the overall length and maximum width of the vessel as defined above)

### 3.3. Basin lockers passing

It is levied on all ships which require a manoeuvre of the Basin lockers pass the following fare:

- » Per operation: **205.03 € excl. taxes**

The following ships are exempt from this fare:

- » Ships performing commercial operations;
- » Vessels used to assist ships, in particular for piloting, tugging, mooring and rescue missions;
- » Vessels engaged in waste recovery and fight against pollution;
- » Vessels assigned to maintenance dredging, maritime signalling, fire-fighting and administrative services;
- » Vessels in forced break that do not perform any commercial operations.

## 4. Shipbuilding and Repair Centre

The services required are accepted and executed on a case by case basis, an estimate is offered to the customer. Upon acceptance of the estimate, a deposit shall be paid in accordance with the operating regulations. The period of validity of the estimate will be specified on the latter.

#### Reservation of docks at GPMLR:

The reservation is subject to a deposit payment calculated as follows:

- Deposit amount = 20% x total period of booking x "Cost of occupancy of docks per vessel and day booked"

In case of cancellation of the reservation docks, the deposit will definitely kept by the Port based on the following tapering scale where J is the date of dock drying booked by the customer:

- 100% in case of cancellation between J and J-21;
- 75% in case of cancellation between J-22 and J-45;
- 50% in case of cancellation between J-46 and J-60;
- 25% in case of cancellation between J-61 and J-90;
- 10% in case of cancellation before J-91;

In every case, a minimum of 1000 € excl. tax will be kept.

#### 4.5. Stay of passenger transport or servitude vessels afloat

For any stay of a ship afloat on the Quai Camaret, on the Epi Central, at the 519° (AP04) mooring pontoon, dock usage fees will be applied, calculated as follows, from the first day if and only if the shipowner orders services from the PRCN or a PRCN company within 6 months of the ship's entry (excluding specific stay agreement contracted with the Port):

## 6. Intellectual services and studies

The Port provides free of cost many traffic indicators. These include the following documents:

- » Monthly, quarterly and annual documents as specified in "technical reference for the electronic transmission of port statistics" detailed in the JO (government gazette) of 31/08/2010, Annex to the order of 06/07/2010.
- » Documents already formalised transmitted weekly to the press.
- » Detailed reports of tonnages of the Port forwarded to the Ministry, to the Prefecture, other Ports and possibly other public institutions.
- » Detailed table of calls for each agreement of terminal.
- » Monitoring indicators of tonnage circulated via the internet communication medium of the GPMLR.

Any additional request for statistics on tonnage transited through the Port of La Rochelle or special studies will be invoiced on the basis of elements defined below. However, the Port of La Rochelle is entitled to refuse any demand that could compromise competitive and/or confidential information.

### 6.1. Indicators already monitored by the GPMLR

- » Monthly list of ships (with details of the tonnage and the berthing dock): 532.05 € excluding taxes per month, based on one request per week.
- » List by tonnage per berth on dock: 532.05 € excluding taxes per month, based on one request per week.

### 6.2. Indicators not monitored by the GPMLR

For all other requests, an estimate will be given based on the number of hours of work involved, at a price of **95.72 € excl. tax/hour**. The time frame for submission of the study will be ten (10) business days or more.

- » Particular case of rolling train sets not providing transportation, loading and/or unloading of port goods on the port railways, or merchandises to or from an ITE connected to the port rail transit system (trains of non-port goods, passenger trains - AGV, TGV, Corail, commuter trains, trams, etc., worksite train sets, etc.) or work on behalf of the Port: **2065.67 € excl. tax per entry on the port rail transit system**

### 9.3. Opening the P post after official hours defined in annex 3 of the DRR and during public holidays

The access to the Port rail network is possible outside the weekly schedules defined in DRR-annex 3 and on public holidays.
